At BCPS we have a school dog: Our School dog has an owner and goes home with them at night and is being trained in the environment, well socialised, and insured to be in school. Dogs need to be under control and supervised at all times and require a quiet place where they can choose to go for alone time (dogs like regular sleep and rest throughout the day). Like all dogs, they will need to be well exercised, given a good diet and provided with enrichment to keep them happy. It's also key for owners taking a dog into a school to have an excellent understanding of dog body language and a brilliant relationship with the pet. |  |

Information is also displayed by the goats and in the food storage shed. Children will be encouraged to engage fully with the Goats and any other pets, feeding and caring for them, grooming them and keeping them engaged with regular visiting, handling, caring etc. adults will accompany children at all times.  |  |

Have the pets been vaccinated against known diseases?                                  | Yes, the goats have been purchased from Carol Partridge, all handling forms etc. have been completed, they have had all their vaccinations. Yes, the school dog has had all vaccinations. Flea treatment is carried out at monthly intervals. Worming treatment is carried out compliant with European Vet guidelines, at 3 monthly intervals. The dog will not go in the school dining hall at mealtimes; he will not be permitted into the food preparation area of the kitchen or the Food technology room  |  |

School toilets and most classrooms have sinks with soap and hand dryers or paper towels, we also have bottles of sanitiser available.   |  |
| Is appropriate personal protective clothing/equipment available e.g. gloves, dust masks and aprons? | Children/adults cleaning the goats house need to wear plastic gloves. Shoe protectors or wellies used by children and staff.   |  |
| Is the housing and enclosure inspected on a regular basis for damage?                               | Yes, the maintenance team will do regular inspections of the house and enclosure including the patio, benches and goats climbing frame. The hay rack, feeding trough and water buckets will also be checked.  This would be the same for any other pet at the school.  |  |
| Allergic Reactions  Do staff or pupils have any known allergic reactions to animals, bedding, feed? | Parents have been asked to inform the school of any known allergies, those with allergies would be able to opt out of interaction. Children will be taught to wash their hands after active interaction.  If a child should show signs of an allergic reaction to any school pet, then appropriate first aid will be given, and the parents will be informed.  Children will be given strict instruction to not eat any of the food intended for the animals or their droppings. |  |

All animals will attend the vets' regularly to make sure they are in good health, or the vet will visit. |   |  |
