Part A: Pupil premium strategy plan

Statement of intent

As part of Cornerstone Academy Trust, at Monkerton Primary we seek to create and promote a challenging learning environment that inspires children to achieve high standards and become life-long independent learners. We work to set consistently high expectations, build children's confidence and ensure engagement for all. In each of our schools we endeavour to develop creative thinkers, inquisitive questioners and avid problem solvers, with flexible skills, who are successful communicators. All children learn to collaborate effectively at all levels, including working with our international partners, and adapting to the needs of a diverse and ever-changing society. By embracing technology as part of everyday teaching, our schools take a new approach to digital tools, embedding their use within a broad and balanced curriculum. We offer and promote a challenging computational learning environment. The children are taught from an early age to program, to develop good logical thinking skills, to solve problems and to collaborate effectively with their peers.

Our motto across The Cornerstone Academy Trust (TCAT) is "Fortune Favours the Brave" and our values include individual liberty and respect for other religions and cultures. These are discussed explicitly with the children during assemblies, and they are reinforced during class time.

Our intention is that all pupils, irrespective of their background or the challenges they face, make good progress and achieve high attainment across all subject areas. The focus of our pupil premium strategy is to support disadvantaged pupils to achieve that goal, including progress for those who are already high attainers.

We will consider the challenges faced by vulnerable pupils, such as those who have a social worker and young carers. The activity we have outlined in this statement is also intended to support their needs, regardless of whether they are disadvantaged or not.

High-quality teaching is at the heart of our approach, with a focus on areas in which disadvantaged pupils require the most support. This is proven to have the greatest impact on closing the disadvantage attainment gap and at the same time will benefit the non-disadvantaged pupils in our school. Implicit in the intended outcomes detailed below, is the intention that non-disadvantaged pupils' attainment will be sustained and improved alongside progress for their disadvantaged peers.

Our approach will be responsive to common challenges and individual needs, rooted in robust diagnostic assessment, not assumptions about the impact of disadvantage. The approaches we have adopted complement each other to help pupils excel. To ensure they are effective we will:

- ensure disadvantaged pupils are challenged in the work that they're set

- act early to intervene at the point need is identified
- adopt a whole school approach in which all staff take responsibility for disadvantaged pupils' outcomes and raise expectations of what they can achieve.

Challenges:

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

Challenge number	Detail of challenge
1	Assessments, observations, and discussions with pupils indicate underdeveloped oral language skills and vocabulary gaps among many disadvantaged pupils. These are evident from Reception through to KS2 and in general, are more prevalent among our disadvantaged pupils than their peers.
2	Assessments, observations, and discussions with pupils suggest disadvantaged pupils achieve at a significant lower level than the non-disadvantaged peers. At KS2 only 20% of PP children passed their Reading and Maths SAT examinations. On entry to Reception class in 2024/25, the pass rate is better, with 71% of children achieving ARE for Number and Comprehension. This compares to 84% (Number) and 87% (Comprehension) for non-disadvantaged children. From an early point, there is a difference, which widens over time.
3	Our assessments (including wellbeing survey), observations and discussions with pupils and families have identified social and emotional issues for many pupils, notably due to bullying and a lack of enrichment opportunities. These challenges particularly affect disadvantaged pupils, including their attainment. Any PASS data?
4	Our attendance data over the last term indicates that attendance among disadvantaged pupils was 90.71%, compared to 96.61% for non-disadvantaged children. Our assessments and observations indicate that absenteeism is negatively impacting disadvantaged pupils' progress.

Intended outcomes

This explains the outcomes we are aiming for **by the end of our current strategy plan**, and how we will measure whether they have been achieved.

Part B: Review of the previous academic year

Outcomes for disadvantaged pupils

Evaluation of outcomes at Monkerton Community Primary School (2024–2025), with a focus on disadvantaged pupils

Outcomes at Monkerton Community Primary School in 2024–2025 present a broadly positive and developing picture. Early attainment is strong overall, particularly in phonics, and attendance and behaviour are clear strengths. However, detailed subgroup analysis shows that disadvantaged pupils begin from a weaker starting point and, while early improvement is evident, attainment gaps are not fully closed and begin to re-emerge through Key Stage 2. As a new and growing school, there are no Year 6 outcomes yet available; therefore, this evaluation draws on early years data, phonics, Year 4 MTC, and attendance to assess trajectory.

Context

Monkerton is a growing school with over 400 pupils on roll, above national averages. The proportion of pupils eligible for FSM (11.5%) is below national averages, as is the proportion with EHC plans, while SEND support is broadly average.

Although overall disadvantage is lower than national, there are identifiable vulnerable groups, including pupils with SEND and communication and language needs. As the school has not yet reached its first Year 6 cohort, evaluation focuses on early and mid-phase indicators and emerging patterns over time.

Early Years Foundation Stage (EYFS)

EYFS outcomes are strong overall, with 78% of pupils achieving a Good Level of Development, above the national benchmark (67.7%).

However, subgroup analysis reveals significant disparities:

- Pupil Premium pupils: 25% vs 81.8% non-Pupil Premium (gap ~56pp)
- FSM pupils: 0% vs 82.1% non-FSM
- SEND pupils: 21.4% vs 95.6% non-SEND

These differences indicate that disadvantaged and vulnerable pupils start from a significantly lower baseline, despite strong overall outcomes.

Year 1 Phonics Screening Check

Phonics outcomes are a strength overall:

- 93.3% achieving expected standard, above national (80%)

However, gaps remain evident:

- Pupil Premium: 63.6% vs 100% non-Pupil Premium
- FSM: 60% vs 100% non-FSM
- SEND: 66.7% vs 100% non-SEND

This indicates that:

- Early reading provision is highly effective overall, but
- It does not fully close gaps established in EYFS

Year 4 Multiplication Tables Check (MTC)

The MTC shows attainment broadly in line with national averages:

- 48.4% achieving full marks vs 48.5% nationally

However, gaps are emerging:

- Pupil Premium: 33.3% vs 50.9% non-Pupil Premium
- FSM: 33.3% vs 50.9% non-FSM
- SEND: 16.7% vs 60.9% non-SEND

This suggests that:

- Fluency is secure for many pupils, but
- Disadvantaged gaps are widening by lower Key Stage 2

Key Stage 2 (emerging outcomes and trajectory)

As Monkerton is a new school, there are no Key Stage 2 end-point outcomes yet available.

However, the available evidence indicates a clear trajectory:

- Strong overall outcomes in EYFS and phonics
- Significant gaps present in early years
- Partial recovery in phonics, but not full closure
- Re-emerging gaps in MTC

This suggests that:

- Early provision is strong, but
- Gaps are likely to widen over time unless addressed consistently

Attendance, behaviour and pupil attitudes

Attendance is a significant strength:

- 96.1% (today), 96.3% year-to-date, above national (94.7%)
- Pupil Premium: 94.1–94.7%, above national (~92.3%)

Persistent absence is very low:

- 4.4% vs 13.3% nationally (below, statistically significant)

Behaviour is also a clear strength:

- 0 suspensions and 0 exclusions

This indicates that:

- Pupils are present, engaged, and able to learn
- Disadvantage is not compounded by absence or behaviour

Overall evaluation

Taken together, the evidence presents a clear and well-evidenced pattern.

At Monkerton, pupils achieve well overall, particularly in the early stages, with strong phonics outcomes and excellent attendance providing a solid foundation for learning. However, disadvantaged pupils begin from a significantly weaker starting point in EYFS, and although they make progress in early reading, attainment gaps are not fully closed.

By lower Key Stage 2, these gaps begin to re-emerge more clearly, particularly in mathematical fluency, as evidenced by the MTC outcomes. This indicates that the challenge is not initial provision, but the consistency with which early gains are sustained over time.

Importantly, behaviour and attendance are strengths, meaning that differences in attainment are not driven by engagement or access to school, but by the depth and consistency of learning across groups.

Overall, Monkerton is a school with:

- Strong early provision and engagement
- Effective phonics teaching
- Excellent attendance for all groups

However, to ensure this strong trajectory is sustained, the key priorities are to:

- Close gaps earlier in EYFS and Year 1
- Ensure phonics success translates into broader attainment
- Secure mathematical fluency consistently, particularly for disadvantaged pupils

This will be critical to ensuring that current cohorts achieve in line with their peers as the school moves towards its first Key Stage 2 outcomes.
